Washtenaw County Updates

Eggermont provided an update that there is a potential for Extended Producer Responsibility (EPR) legislation in Michigan to be drafted in the next year that would create a system where packaging producers would subsidize recycling by paying into a fund that would distribute money to Materials Recovery Facilities and municipalities. It would not take away individual municipality's authority to set up their own services but would create a payment structure to direct money from packaging producers to municipalities to help pay for recycling.

Auth asked if there is any update on the plastic bag ban legislation. Eggermont responded that there are discussions in the legislature, and we anticipate it coming up next year. Eggermont added that at the county level a tax would be implemented rather than a ban because research suggests that approach reduces more plastic.
