Unfinished Business

RFP Discussion

Davis provided an update that he had all positive experiences when presenting about the collaborative RFP at Ypsilanti Township, City of Ypsilanti, City of Dexter, and Pittsfield Township. He requested that the five communities that are interested in moving forward with the RFP send him information about their community's collection service needs.

Wessler arrived at 11:07 a.m.

Davis reminded the board that the contract will be between WRRMA and the hauler. The participating communities will have a separate contract with WRRMA as a group that pledges each community's waste and recycling to WRRMA. Therefore, the payment will be consolidated, and a structure will need to be put in place to make the payments to the contractor(s). Davis asked that communities read closely the provision for a one percent rebate that comes off the payment amount if the payment is made within a certain time. He noted that money could be used to fund office staff to administer the contract.

Colvin-Garcia arrived at 11:09 a.m.

The board discussed contract language that would give other WRRMA communities the option to join the contract later, how revenue-sharing works, accepted items for recycling, and the potential to include food waste collection service.

Wessler pointed out additional considerations and services that the City of Ypsilanti has. Davis encouraged the participating communities to send him all their community peculiarities and desired inclusions for services.

Eggermont mentioned there was a previous discussion about allowing other entities such as Washtenaw Community College, Eastern Michigan University, and the University of Michigan to be customers in the contract. Davis responded that other authorities have done this, and the entities are considered "clients" that are added through a contract amendment rather than listed in the initial RFP.

Member Reports

Mason provided an update that the public engagement sessions for the new Drop-Off Station have been concluded. One site concept has been finalized and they are currently working on documentation for submittal to the Pittsfield Township planning commission. Pending approval, the city will be soliciting construction bids with the goal of starting construction in the spring of 2024.

Washtenaw County Updates

Porta provided an update that the County held its first Clean-Up Day of the year on June 24 at Whitmore Lake High School. Porta noted that registration improved traffic flow, which made the event a more positive experience for residents, staff, and volunteers. Porta shared that the county is seeking additional volunteer assistance at the events and asked that communities help share this information.
